- **For drug companies:** Have not yet submitted an Investigational New Drug (IND) application to the US Food and Drug Administration

- **For device companies:** Have not received commercial approval, authorization, or clearance from the US Food and Drug Administration
- **For companies outside the drug/device categories:** Eligibility will be determined on a case-by-case basis

2. **The Corporate Advisory Board** will hold a meeting prior to the ASRS Mid-Year Board Meeting with the ASRS leadership for a strategic discussion about how the Society and industry can work together to improve patient care and ways of further educating the membership about developments in research and treatment of eye diseases.
